Every player is required to be a current US Lacrosse member. **(except boys in Learn to Play)** We will not process registration forms that do not have a membership number and expiration date.

Your cancelled check or charge to your card is proof of registration.

Schedules and team assignments are posted on the website. Registration goes up to the 1st day of the session, so all assignments are tentative until the first game.

Boys will have one game each week at one of the times listed on one of the days listed. Please print out a copy of the schedule.

We encourage and promote good sportsmanship. This means that we reserve the right to remove any player from instruction or competition if they display poor sportsmanship or are disrespectful to our staff or other participants.

## Registration Fees

Refunds will be made in full when registration is cancelled at least **15 days** prior to the start of the session.

50% of the fee will be refunded when registration is cancelled **14 days to 1 day** prior of the start of the session.

**NO REFUNDS** as of the **first day** of the session.

Registration may not be transferred to another player.

## Equipment Requirements

**Boys playing games will need:**

Helmet, stick, cup, gloves, arm and shoulder pads and a **MOUTH PIECE**. Each player must also bring the reversible **ASSIGNED TO HIM** each week.

If a player does not have all of these things, they will not be able to play that week.

**Boys participating in Learn to Play are required to have a stick.** For the best experience, full equipment is needed. However we understand this may not always be possible so bring any equipment you have.
